## **Annual Report Narrative**

2014-15 has been a fruitful year for the Library. After two consecutive years of financial crisis, RMRL has received project grants and funds this year. The Library received two major grants – one from the Navajbai Ratan Tata Trust for undertaking paper conservation work. Through this project, RMRL will be setting up a conservation studio and will be conserving rare imprints in its collection. We strongly trust this project will become a model for undertaking paper conservation in India. The second is from the Endangered Archives programme (EAP) to digitize rare imprints. RMRL has started the digitization work and field visits are being made in various parts of south India in search of rare imprints.

In addition to the project grants, the Library also received a few donations towards a corpus. As in the past many new people have donated books. To deal with space issues new compact shelves have been ordered to stack new donations.

An endowment has been constituted this year to honour Prof. V. Arasu who retired recently from the University of Madras. A fund has been endowed in his name as "Prof. V. Arasu Endowment Lecture Series" by his students.

To boost research activity in Indus Research Centre, a bulletin authored by Dr. Iravatham Mahadevan has been published as "Dravidian Proof of the Indus Script via the Rig Veda: A Case Study". This emphasizes the need for multilingual research especially in Tamil, Sanskrit, Pali and other languages. In order to expand as a research institution RMRL has been approaching some of the renowned universities for affiliation. This will help scholars to undertake research in house utilizing RMRL's material.

RMRL has been approaching corporates to get funds through Corporate Social Responsibilty. Thanks to the Government of India for including libraries and heritage institutions to be supported by CSR. RMRL sees hope in the future for taking up more activities.



#### Reference Services

1610 scholars visited the Library for their research work during this year. As in the past M.Phil. and Ph.D. scholars as well as writers, freelance researchers and journalists have used the collection. 4857 books and 6,983 periodicals have been put to use multiple times. In addition to the above figures, several scholars have received support over telephone and email services. Microfilms are also being put to use for their research work. In addition to the existing OPAC system in the reference section, two systems have been installed with JISIS database for convenience of the scholars. The data can be searched in Tamil using UNICODE.

## **Documentation and Acquisitions**

7306 books were catalogued this year. This includes 1469 books from Mu. Arunachalams' donation. These books were catalogued and now available in our online database for the educational community. The breakup of the catalogued books is given in the table.

Cataloguing of late Mu. Arunachalam's collection has been started. 2300 books were catalogued and the work is in progress.

Now, RMRL has online database in J-ISIS platform and it is accessed both internally and externally by the scholars. We have been experiencing the shutdown of the server. All efforts are being taken to resolve this issues.

## **Reprographic Services**

RMRL has taken up the work of identification and digitization of rare Kannada imprints. This is through the funds the University of Chicago (UoC) received from the Endangered Archives Programme last year. As a trusted collaborator of UoC in India, RMRL has taken up this preservation assignment. Field visits are being undertaken in both Tamilnadu and Karnataka and rare materials have been identified. Digitization work has been started and it is in progress.

RMRL completed the digitization of Census of India volumes published in the years 1921, 1931 and 1971. To complete the quality control of digitized microfilms staff have been recruited and trained. GKD Charitable Trust has donated amount to undertake this work. The work has been going in full swing and will be completed soon.

Considering the safety of the digital content RMRL has generated in the past two decades a mass storage device has been purchased and installed in the Library. The process of transferring the digital content is under way.

## Indus Research Centre (IRC)

During 2014-15 the Indus Research Centre (IRC) did not attract any new research projects or funding. And this has affected IRC plans to expand the Indus Concordance and make it available to the public in electronic form.. RMRL is working with Tamil University, Thanjavur, for affiliation so that IRC can formally conduct research activities in several areas including the Indus Valley Civilization and its script.

#### Research Activities

IRC is collaborating with the Institute of Mathematical Sciences in the area of Indus text analysis, specifically in the area of text segmentation. IRC continues to build on its collection of Indus research and reference materials. Dr. Iravatham Mahadevan has made a breakthrough in the analysis of the Indus script using his interpretive approach. His latest interpretations have been published by IRC as the fourth issue of the Bulletin of the Indus Research Centre and titled "Dravidian Proof of the Indus Script via the Rig Veda: A Case Study" Two articles, சிந்துவெளிப் பண்பாட்டின் வீழ்ச்சி & சிந்துவெளி எழுத்தாய்வுக்கு ஹேராஸ் பாதிரியாரின் பங்களிப்பு were written by Mr. C. #### Accounting Policies

## i) Accounting convention

The financial statements are prepared under the historical cost convention on accrual basis of accounting.

#### ii) Use of estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of revenues and expenses during the period reported.

### iii) Revenue Recognition

The Income from Digitisation, Documentation, Reprographics, Training and Reference Services is accounted on Accrual basis.

Donations are accounted on Receipt basis. Interest is accounted on Accrual basis.

Project Work in Progress has been recognized on percentage of completion basis.

#### iv) Fixed Assets

The Fixed Assets other than the Books owned by the Library are accounted at Cost and depreciated over the useful life of the asset.

The books & periodicals purchased for the collection are recorded at cost and not depreciated.

The books and periodicals received as donation are valued at fixed prices depending on the age of the book or periodical. These rates have been approved by the managing committee after considering the practices followed by similar organizations. These assets are not depreciated.

#### v) Depreciation

Depreciation on fixed assets is provided on written down value method at rates arrived at based on the useful life of the asset.

Depreciation in respect of additions made during the year and put to use for less than six months has been charged at 50% of the original rate for the block.

#### vil Investments

Investments are recorded at Cost.

#### vii) Foreign Currency Transactions

Foreign currency transactions are recorded at the rates prevailing on the date of transaction.
